Empowering Freedom from Domestic Violence

Friendship Home's vision is that someday, the need for our services will cease to exist, that no one in the community will tolerate domestic violence, and that all homes will be places of love, support and safety.

For over 45 years, Friendship Home has provided support, shelter, and advocacy for survivors and their children who have experienced domestic violence, sexual violence, dating violence, and stalking. Our staff respects that each survivor knows their situation best and that they have the right to decide what happens next in their journey.

Emergency Shelter

Friendship Home is the only emergency domestic violence shelter in Lincoln and Lancaster County, focused on providing safe, secure, and confidential shelter options for survivors and their children when their risk of violence is at its greatest. Trauma-informed shelter options include communal shelter and singlefamily apartments. Our Services



Crisis Services

Friendship Home's crisis services offer caring protection from domestic violence - safety planning, case management, advocacy, crisis counseling, access to medical and behavioral health services, financial aid, transportation, short-term mental health services, and support groups.

Transitional Housing

Survivors focus on financial literacy, learning to track expenses, budget, and build credit. Our transitional shelter program offers direct case management along with assistance navigating community resources. Survivors have the support they need to find a job or obtain job training, locate childcare, and secure permanent housing.



Rapid Rehousing

Short-term rental assistance and supportive services are provided to households experiencing homelessness due to domestic violence. The resources and services provided are tailored to the unique needs of each household. Rapid Rehousing is an intervention designed to help survivors quickly exit homelessness and return to permanent housing. Intensive case management services are offered to address barriers to housing stability.



⁶⁶ Friendship Home extends beyond being just an emergency shelter; it's a place where advocates are constantly confronted with the heartbreaking aftermath of domestic violence, evident in the pain carried by the youngest survivors. Ensuring the strength of the parent-child bond is crucial for fostering resilience and minimizing harm in children, mitigating the impact of domestic violence.

Children's Advocates (CA's) work extensively with parents in shelter, providing advocacy and support that helps them strengthen bonds with their children. CA's provide education on the impact of domestic violence on their children's development, asses their children's physical and psychological needs, and offer information on community resources that may be helpful to their family. Through skillfully prepared activities, they begin to share their stories, their fears, and their hopes. Safety planning is discussed in practical, age-appropriate ways, reducing their sense of powerlessness.

2023 Accomplishments

- In 2023, Friendship Home actively participated in a community safety needs assessment with other community agencies, focused on learning from survivors through their experiences with local agencies.
- Friendship Home worked on organizational strategic planning efforts to establish an enhanced and inclusive work culture, create sustainable funding for expanding services, and continue improving community knowledge of services.
- Friendship Home performed an agency-wide database migration to Vela, which has had a significant impact on reporting, client documentation, and staff training. Vela is a unique data collection and reporting site used to meet the needs of Domestic and Sexual Violence Programs.



It takes courage to leave an abusive relationship; to create a life free from violence is not an easy decision to make. Friendship Home strives to create an environment where all survivors can grow and heal. We take a unique approach by providing Strengths-Centered Advocacy, offering survivors the opportunity to discover and apply their strengths to assist in recovering from the traumatic effects of domestic violence.

Strengths-Centered Advocacy has flourished at Friendship Home over the last twenty years. Using strengths allows advocates to deepen their understanding of each survivor and more meaningfully individualize support and services.

Upon discovering their strengths, many survivors shared that their abusers had attempted to make them feel their strengths were weaknesses. One survivor said...

"For so many years, he tried to take everything from me. But seeing my strengths, I realize it was one thing he couldn't take away. They were always within me, and still are."

Since implementing strengths-centered advocacy, we have seen a significant change in survivors and their children. Strengths-centered advocacy provides a path to help strengthen the relationship and connection between survivors and their children and deepen their understanding of each other. It is one of the many ways we strive to create a healing, welcoming, and empowering environment for all.

1,664 Survivors received shelter and/or crisis services

922 Requests for safe shelter were compassionately addressed

529 Survivors of domestic violence were sheltered; 302 were children

49,539 Meals were served

46,269 Bed nights were provided

The amount of time each survivor is staying in Friendship Home's emergency shelter has increased from 5.87 weeks on average to 6.2 weeks.


Money Matters

In 2023, 56% of our income came from Grants and Government support, 31% from Donations and Special Events and 13% from United Way, the City of Lincoln, and the State of Nebraska.
